- Use Extension approved curriculum and materials
- Actively recruit members to participate in 4-H on local, area, state and national levels
- Actively recruit assistants, parents and other unsalaried positions for help or future Master School Club facilitators
- Meet monthly with Extension staff or 4-H Council to discuss progress issues, ideas and new recruits
- Hold (2) yearly meetings with educators to plan and evaluate program.
- Host area/state training

- Must undergo the Kentucky 4-H volunteer application and screening process and be accepted as a volunteer.
- Minimum 1 yr. classroom experience (such as Retired Teacher, Title 1 Worker, Substitute, Tutor)
- Minimum High School diploma
- Independent transportation
- Good working rapport with School Administration and Board Of Education officials
