#### **POSITION TITLE:**

County 4-H Financial Manger

#### TIME REQUIRED:

5 hours per week (approximate) for 2 years beginning September 1 - August 31

#### LOCATION:

County Extension office, local bank, and/or investment firm

#### **GENERAL PURPOSE:**

- Secure funds from fund-raising coordinator
- Serve as liaison between county Extension office, investment firm and fundraising coordinator
- Serve as ex-officio member of county 4-H council
- Meet with 4-H agents to determine financial goals and future needs of the 4-H program

#### SPECIFIC RESPONSIBILITIES:

- Manage funds for county 4-H council
- Provide insight into potential investments
- Conduct financial transactions for 4-H council
- Oversee general well-being of 4-H finances
- Maintain accurate financial records and report standings at council meetings

#### **QUALIFICATIONS:**

- Must complete the Volunteer Application process and be approved by the Youth Protection/Risk Management Committee
- Possess knowledge and understanding of financial management, investment banking, or financial planning
- Previous experience as financial manager
   Ability to work and communicate in verbal and written form
- Acceptance to being bonded
- Prior knowledge of Kentucky 4-H program, its philosophy and guidelines
- Prefer certified financial manager
