#### **POSITION TITLE:**

County Field Day Coordinator

#### TIME REQUIRED:

Monthly committee meetings for four months prior to Field Day; 3- 4 days (before and after) the Field Day for preparation, setup, and take down.

#### LOCATION:

Committee meetings will be held at the Extension office; 1-2 months prior to Field Day, some committee meetings will be held at the host farm.

### **GENERAL PURPOSE:**

Work with other volunteers to identify programs to be conducted at Field Day; Set up these programs with Extension staff, specialist, and needed volunteers; Coordinate committee to conduct the event.

#### SPECIFIC RESPONSIBILITIES:

- Select host farm
- Lead committees by assigning task necessary to have a successful event
- Gather information (evaluate) for improving subsequent events

- Good relationship with farming community
